- **2.4.** Data that the website collects automatically while browsing, if you have previously given your consent in the terms specified in this Privacy Policy.
- **2.5.** We collect information about how you use our Website through the use of cookie technology. For more information on how we use cookies, please see our Cookie Policy.
- 2.6. Lastly, if you have consented, sending commercial communications with information on new services, events, participations, collaborations or publications, among other content. We hereby inform you that the personal data processed by SHACKLETON will not be used for different or subsequent purposes. If necessary, we will inform you of any relevant changes in this regard and request your renewed consent.

3. HOW LONG WILL WE KEEP YOUR PERSONAL DATA?

We would like to inform you that, at **SHACKLETON**, we process and store your personal data as long as professional contact is maintained. We are subject to various different storage and documentation obligations, so the period of retention of personal data may be subject to different variations, and may be stored for up to:

- 4 years: General Tax Law.
- 6 years: Article 30 Commercial Code (accounting records, invoices, etc.).
- 10 years: Article 25 Law of 10/2010, of 28 April, on the Prevention of Money Laundering and Terrorism Financing.

If you have accepted and consented to our sending you commercial communications, personalised advertisements, studies and surveys related to **SHACKLETON**, we will keep your data from the time you subscribe until you request to unsubscribe.

In the event that the data are no longer necessary for the fulfilment of contractual or legal obligations, they will be deleted periodically (approximately every 2 years), unless their further limited processing is necessary to fulfil the purposes and obligations cited above.

4. WHAT IS THE LAWFULNESS OF THE PROCESSING OF YOUR PERSONAL DATA?

- **2.** The right to request a restriction of the processing of your personal data. In this case, **SHACKLETON** will only keep your data for the exercise or defence of possible claims.
- **3.** The right to object to processing, in which case **SHACKLETON** will stop processing the data in the manner you indicate, unless we have to continue processing your data for lawful reasons or for the exercise or defence of possible claims.
- **4.** The right to data portability. If you request that your personal data be processed by another entity, **SHACKLETON**, whenever technologically possible, will facilitate the portability of your personal data to the new data controller indicated to us.
